BACKGROUND AND DISCUSSION

As of today, the balance in our checking account is \$145,717. The savings account balance is \$65,251.

We are seeing positive gains in Annual Conference Registration revenue; currently at 57% to our budgeted amount with more than one month away until the close of registration. Currently, we've had one expense towards Annual Conference Expenditures and that was for the Whova App. I'm currently working with Annual Conference Committees to submit payments for services, e.g., DJ, A/V.

Overall, our expenditures are at 48% of budget and our revenues are on track to meet budgeted amounts at 85%.
