#### 4. EXECUTIVE BOARD / ANNUAL CONFERENCE UPDATES

#### **❖ PRESIDENT'S REPORT**

- President Murguia provided an update on the Strategic Plan that was started at the Board of Directors Meeting on February 18.
- o President Murguia provided an update on the Signature Events for 2020.
  - Due to the COVID-19 pandemic, the Summer Session and Women's Leadership Summit were both cancelled. However, the Summer Webinar Series was rolled out and over 350 attendees participated in the nine webinars. The Fall Webinar Series will be from September 3 October 8. Each webinar is in partnership with our Corporate Partners and Affiliate Partners.
  - The 2020 Annual Conference is scheduled for October 26 29.

- The Programming Committee will be working on finalizing the Agenda this month.
- The Annual Business Meeting is scheduled for Wednesday, October 28.
- The Bylaws and Elections Committee is working on the materials that need to be sent out to the membership.

### **❖ DIRECTOR OF PROGRAMMING'S REPORT**

Director of Programming provided an update on the status of Region Events and Programs. He reminded everyone to post their Events and Programs to the MMASC online calendar and work with Director of Communications / Secretary Spiegel for the marketing materials.

#### **❖ DIRECTOR OF MEMBERSHIP SERVICES' REPORT**

- ❖ Director of Membership Services Hallett Hinton provided a membership update. As of August 14, the membership stands at 812.
- ❖ Director of Membership Services Hallett Hinton provided an update on the 2020 Annual Conference.
  - i. Registration is now open. Business, Full, and Veteran Members is \$75; Nonmembers is \$175 (\$85 registration + \$90 one-year membership); Student Members is \$50.
  - ii. The Annual Awards & Scholarships are open.
    - 1. Nominations for the Annual Awards are due by Thursday, September 3.

- 2. The deadline for Scholarship applications to the MMASC Annual Conference and the ICMA Annual Conference is September 4.
- 3. Over 50 sessions were submitted this year. The Programming Committee is reviewing each of them and finalizing the schedule.

  - ❖ MMASC's networking ability: It grows each year, we maintain the network and having it as a continuous wheel − based on existing and new members − allows for many opportunities. Whether connecting with members at events and programs or through the mentorship program, the one-on-one connections continue to be a valuable asset to many.
  - ❖ We (MMASC) are connecting with our members (and each of us are connecting with our communities) in different ways − text messages, emails, social media posts, printed materials, transitioning events to virtual events (on Zoom, Microsoft Teams, Cisco Webex, etc.).
  - ❖ There are areas of opportunity for the Association to become more meaningful moving forward including expanding the Listerve and make it an archive-based tool that members can refer to in the future; membership engagement and creating a Dashboard/Database resource for members.
